1. Call to order

Called to order at 12:14 p.m. by Patti Bannister.

2. Approval of the agenda

Lorraine Slopek motioned to approve the agenda; Jennifer Copage seconded the motion.

3. Approval of the 2012 AGM minutes

Peter Crowell motioned to approve the minutes. Pauline MacLean seconded the motion.

4. Business arising from the minutes

No business arising was noted.

5. President's Report (includes summary)

Patti Bannister delivered the president's report in lieu of Catherine Arseneau's absence. Patti gave some of the highlights of the past year, including the cancellation of the National Archival Development Program (NADP) and noted how CNSA advocated to the federal government in various ways to re-examine the program's cancellation.

Patti noted that the president of CNSA (Catherine Arseneau) served on the Public Archives of Nova Scotia (PANS) board of trustees, which is currently in the midst of a legislative review of the Public Archives Act.

She also noted the CNSA's ongoing liaison efforts between the department of Communities, Culture, and Heritage (CCH) and the Nova Scotia Archives. There is an ongoing commitment from CCH to work with CNSA as demonstrated through the granting of a one-time \$30,000 ministerial top-up grant.

The prospect of a heritage advisory council that would include CNSA has been raised and a meeting with government officials was held in April, 2013.

CNSA was awarded funding for two Provincial Archival Development Program (PADP) projects. One project was for cleaning and migration of the existing Archway data, as well as to provide funds for a meeting held in February 2013 for representatives from across the Atlantic region to update on each jurisdictions' descriptive databases and to explore potential options for collaboration among the provinces.

The CNSA's Introduction to Archives course, offered through the Nova Scotia Community college was not offered this year, but plans are underway to deliver the course in January 2014, with a second delivery, in an online format, slated for September, 2014.

Jamie Serran was the successful candidate for the Archives Advisor position and began in her new role in March, 2013.

a. Ad Hoc Planning Committee

Patti explained the origins of a new ad hoc planning committee that will be examine many issues related to sustainability and future planning for the CNSA. In particular, the committee will examine some of the core recommendations of the 2007 needs assessment to see what has been achieved and where needs may have changed. The committee will also be examining the PADP in order to ensure that it continues to be as relevant and accessible to the membership as possible. There are ongoing discussions between the CNSA Executive and NSA about CNSA taking on the management of the PADP program. Funds for the committee's operations will come from the one-time ministerial top-up grant. It is

hoped that the membership of the committee will be comprised of a representative cross-section of the CNSA membership.

Peter Crowell asked how often and in what capacity the board meets. Patti responded that the board meets on a monthly basis and that most meetings are held in-person, with some held via teleconference.

6. Treasurer's Report

a. 2012-13 Year end review

Jennifer introduced and highlighted some features of the 2012-13 year end financial review and asked that the membership approve the review.

b. 2013-14 Budget

The 2013-14 draft budget was circulated and Jennifer Copage motioned for it to be approved by the membership. Creighton Barrett seconded the motion.

c. Appointment of 2014 financial review body

A motion was requested that Grant Thorton be approved as the financial review body for CNSA in the 2013-14 fiscal year.

7. Nominations and elections

Patti presented Rosemary Barbour with a token of gratitude for her 20 years of service on the CNSA Preservation committee. She also thanked Catherine Arsenault for her work as President and with the Executive. Jane Arnold accepted the gift on Catherine's behalf.
